Annual Subscriptions allow you to create your own Storefront within the **Classified**. This supplies you with a variety of pages and product/service categories, all of which can be adapted to suit you. Place unlimited* adverts within your chosen package, and manage all your online advertising in one place, without losing sight of the most important thing – your customers.

This guide will take you through the simple steps to subscribing to the **Classified** – Your Local Online Marketplace



STEP ONE: Register

- 1) Find *your* local Classified marketplace visit our <u>Interactive Map</u> and find your area. Click through to your Classified site
- 2) On the homepage click the **Join** button
- 3) Enter all of the relevant information, and remember that fields with a * next to them are mandatory
- 4) Take note of the Username and Password that you create you'll need them every time you log in!
 - Please Note: It is essential that you carefully read and agree to the Classified Terms and Conditions before proceeding
- 5) Click Submit

STEP TWO: Choose the Subscription to Suit You

1) You will be taken this screen, select **Click HERE to** take out an Annual Subscription.

(If you have previously registered you will have been taken to your account homepage upon logging in. On the left-hand side, under Add Items, select **Annual Subscription**) Congratulations!

- Select the Annual Subscription type that suits you for example, if you are an Estate Agent or Property Developer subscribing to unlimited* property advertising, select the Property subscription. If you are an individual wishing to sell a variety of products, select the Items for Sale subscription.
- Click Next to view your total fee, then click Checkout.

STEP THREE: Select Your Payment Method

Ensure that your billing information is correct, and then select your payment method. You can select PayPal (to pay via any major credit/debit card), any existing Account Balance, or Cash. Cash will need to be paid in person direct to your local the **Classified** licensee, and you will be contacted to arrange this. If you select Cash, it is your responsibility to ensure that you can travel to the licensee's location and pay in person, and your account will not be activated until payment has been received.

Please Note: In order to prevent abuse, all Annual Subscriptions must be approved by our team. It may take up to 24 hours to do this; you will not be able to purchase another subscription whilst your purchase is awaiting approval. Once your account is approved, your individual listings will not be subject to approval.

If you have selected PayPal as your payment method you will be taken to a PayPal screen, follow the on screen instructions.

STEP FOUR: Complete Your Profile

- 1) Click My Account Information
- 2) Scroll down and click Edit My Info
- 3) Fill in as many of the fields as you can and save them. Do not fill in any information that you do not wish to be displayed on your listings
 - Tip: Put your address into Google Maps to find your property, and make a note of the way it holds your address. This may differ slightly from the way you normally see your address, but if you enter this in your registration form, it ensures accurate pinpointing of your address on your page and against your listings. If you do not wish to disclose your exact address, simply omit your house name or number. This can also be hidden from your adverts when you list them.
- 4) You will need to enter your current password in order to save your changes. Leave the new password fields blank unless you wish to change your password
- 5) Make sure to select Apply changes to mapping addresses
- 6) Click Save Settings
